## **A Summary of the Law Relating to Home Education**

### **In England and Wales School is not compulsory**

In England and Wales parents have the primary responsibility for ensuring that their children receive an effective education. Although this responsibility is usually delegated to schools, some parents choose to exercise it directly by providing an education based at home.

The legal responsibilities of parents and local education authorities in relation, to elective home education of children of compulsory school age. The responsibility of parents is clearly established in section 7 of the Education Act 1996 (Previously section 36 of the Education Act 1944):

The parent of every child of compulsory school age shall cause he/she to receive efficient full-time Education suitable:

- (a) To his/her age, ability and aptitude, and
- (b) To any special educational needs he/she may have, either by regular attendance at school or otherwise.
